- 1. Meeting was convened at 7:01PM
- 2. Motion to approve the September meeting minutes was made by Com. Scott, seconded by Com, Howard. Motion passed.
- 3. Reports
 - a. Lake Norman Marine Commission Executive Director Morris Sample
 - The current lake level is 97 ft which has increased over the last few days. Please be aware that as we move into winter months, the lake level will likely decrease and some areas that were navigable before may be dangerous at the lower lake level. Please be aware that shoal markers do not cover all the areas that should be avoided at lower lake levels.
 - Please continue to report any surface observations on Lake Norman. We have
 received some reports of algae on the surface and Duke will investigate those findings.
 You can report to aquaticplants@duke-energy.com or visit our website at Inmc.org and
 click on Useful Links, Duke Energy Lake Services. As we get into the cooler weather
 and the lake temperature decreases, the Chara that has been widely reported this
 summer should disappear.
 - NC State is completing their survey of the lake for aquatic weed growth. Will share the findings when they are available.

 Our plan is for future meetings to be in person pending any changes to COVID restrictions at Charles Mack. The next meeting will be Nov 8th and we usually don't meet in December.



Officers responded to 21 calls for service during the month of September with 5 Problem Solving activities. These calls for service were on the lake only. The most calls for service were received on Saturday. Calls for service were most often reported between the hours of 12:00pm-06:00pm. Lake officers conducted 11 vessel stops, 4 written warnings as well as 7 citations. The average response time to calls for service was 8.04 minutes. Officers self initiated 412 zone checks.

September Highlights:

Drowning near marker D6 off of Island Forest Dr. The Captain of vessel "Girl Trouble" observed an operator had fallen off a jet ski and was attempting to swim back to the jet ski. The operator was

seen taking off his life jacket, before submerging and not coming back up. The jet operator's body as recovered approx. 3 hours later.

- Boat crash at Freedom Boat Club. Owner advised he does not know when the crash/boat damage occurred, \$2000 estimate damage
- Lake Patrol crossed trained with both Cornelius and Huntersville K9 units on the water. The K9's Handlers were exposed to the boats and deploying from the boats.
- Report of handgun stolen from boat, Boat owner invited unknown subject for social media site, to their boat and a handgun
 was discovered missing after the visit
- Lake patrol participated in "Operation Wake Surf" photoshoot
- Report of a boat crash at Holiday Marina, both boats left the area prior to officer's arrival, advising a witness there was no damage.
- Lake Patrol Officers participated in the Cornelius Police Department's Citizen Academy
- Civil matter between rental boat owner and renter, a phone had fell into an inaccessible place on a boat. Complainant was advised of how to proceed if nothing could be worked out with the boat owner
- Trespasser's were reported at the Mecklenburg County Water Intake at Blythe Landing. Lake Officers were able to locate 4 subjects and advised them of the restricted area. Subjects moved away from he area
- Multiple officer initiated calls with citizens involving handing out boating safety literature, advising of rental boat laws and general lake safety
