June 12, 2023 Meeting

- The Catawba Wateree Drought Management Advisory Group is holding their annual meeting on June 13th. The Marine Commission will attend this meeting. We are currently out of the Stage 0 drought designation based on recent rainfall.
- Please report any issues with lake markers to the Marine Commission at lnmc.org. For shoal markers, please include the label number on each pole just below the sign. This helps in making sure we have the correct marker. There are currently 194 markers, buoys that we maintain.
- Have received several questions concerning anchoring vessels on the lake. Currently no restrictions on anchoring vessels as long as they display proper navigation lights at night and are not in a main channel area. However, vessels anchored to shore line are subject to restrictions from property owners.
- As lake traffic increases, please notify county lake patrol for obvious violations. This gives them info on where to monitor in the future.

Activity Summary:

The three units operating on Lake Norman were involved in the combined activities listed below. On-water activities are typically conducted on Lake Norman from April 1 – October 30 each year. On-water activities are generally scheduled in 1-2 weeks in advance; emergency callout procedures can be invoked if needed.

Upcoming Events and Items of Note:

- Activities continue to install a USCG Auxiliary Fixed Land VHF Marine Radio Station. Location is Blythe Landing Park with ongoing discussions with Mecklenburg Parks and various funding sources. A Building Permit will be required and an engineering firm is working on drawings needed for the permit.
- May 13 the USCG Auxiliary participated in the "Love Where You Lake" day at Blythe Landing, conducting Vessel Safety Checks and supporting an active duty USCG recruiting event including presence of USCG Auxiliary vessels and a USCG 22ft. response boat.
- May 13, the USCG Auxiliary attended a boating safety booth at the Mooresville Race City Festival with approximately 50 direct contacts made with the public.
- 4. Additional Vessel Safety Checks were conducted on May 13 at Peninsula Yacht Club.
- 5. A boating safety class was held May 20, 2023 at Denver Fire Dept with 13 students in attendance.
- 6. Vessel Safety Checks were conducted at Safe Harbor Kings Point marina on May 20.
- 7. Upcoming on-water operations consist of Marine Observation missions and training sessions.
- 8. Flotilla 26-04 continues to sponsor a Sea Scout ship, conducting training sessions on-land and on-water. During a week in August, various CG Auxiliary members will be hosting the Sea Scouts overnight at their homes at stopover points as the ship canoes down Lake Norman with the purpose of conducting cleanups at various locations.
