ATON Committee

Assistant Director John Gerke reported a phone call regarding the removal of the osprey nests from the ATONS. Lake Norman has reached is capacity on osprey and therefore we are trying to get them to relocate. Report of 2 poles floating.

Environmental/Hydrilla Committee

Committee Chairman Bob Vandola reported signed contract with Jessica of NC State University. She'll be leading the effort for coordinating the treatment for lyngbya. This is being treated as a pilot effort to see what works and how it works. 10 acres have been identified. The protocol is copper based algaecides. They are EPA approved and will not affect swimming and fishing.

Boater Education/Communication

Commissioner Johnson reported meeting updating rental boat and charter boat regulations. 2100% increase from 1985 to 2005 in population for Cornelius and Huntersville. That growth came from the lake. March 18th was the training session for fire and medical. Certificates presented to key parties. Working to support the Blythe safety center with boater safety materials. Working on a deal to get the life rings down to a reasonable rate.

LNMC Minutes continued **Executive Director Comments**

April 8, 2024

- Remain **cautious** for lots of debris still in the water. We have been getting lots of requests about removal of large logs and trees on beaches and to rap. Unless it is a hazard to navigation, natural material will not be removed. Duke Lake Services should be contacted if larger items are man-made or are a hazard. We have suggested lawn or tree services be called for large trees.
- Since our last meeting, the Marine Commission members have participated in several meetings including
 - Catawba -Wateree Management Group's Integrated Water Resources Plan working committee on 14 March. This is a multi-year study to develop water management strategies and tools considering many economic and environmental facors for the long term (through 2100)
 - March 13 we met with managers and commissioners from all our counties, Duke, and Charlotte Water, and our citizens group to update them on the lyngbya plan as well as all of our other major initiatives. They were very supportive and we will plan similar sessions in the future.
 - March 18 we and the Lake Wylie Marine Commission held a work meeting with Duke to address issues which we had brought up in the general sessions of the group working on the **Catawba Wateree Shoreline Management Plan**.
- As a reminder, the Shoreline Management Plan (SMP) is basically the guidelines for any construction, shoreline stabilization or modifications, marinas, etc that touch the shores of any Duke Lake in the FERC project. If you would like to review the document and submit ideas for revisions please contact your Commissioner.
- Also on the 18th there was great fire, emergency, medical training session for captains. I'd like to recognize Capt Ronnie Caldwell for his initiative in organizing this. More from john Johnson during the education committee report.
- Finally, last month we signed contracts for additional stocking of Carp and for the lyngbya treatment program. More about this later from Bob Van Dolah.

Activity Summary:

Upcoming Events and Items of Note:

- Activities continue to install a USCG Auxiliary Fixed Land VHF Marine Radio Station. Location is Blythe Landing Park. A memorandum of understanding between Mecklenburg Parks and the USCG Auxiliary for use of the Blythe Landing facility is in draft stage. Once the MOU is completed, installation of the utility pole to support antennas and the radio equipment will commence. Funds needed have been received. The goal is to have the radio station up and running as soon as possible.
- 2. A boating safety class conducted March 16 at the Denver Fire Dept graduated 23 students.
- CG Auxiliary will participate in Bythe Landing lake safety center opening ceremony on May 18 and will also assist with planning and building setup.
- CG Auxiliary continues to conduct Vessel Safety Checks for rental boats on Lake Norman to provide the safety check required by the LNMC Rental Boat Ordinance.
- 5. CG Auxiliary will participate in portions of Lake Norman first responder / LE training being conducted week of April 8.
